Note:-

1. The Act provides the spirit, and Statute(s) and Ordinance(s) provide flesh and bone for a smooth functioning of the University. The procedure for granting affiliation to colleges is not provided in the Act and is to be laid down in the Statute and ordinance in place.

2. The colleges will have to deposit enhanced endowment fund as per clause 3.2.2 of UGC (Affiliation of colleges by Universities) Regulation, 2009 and clause 3.2.2 of Pandit Deendayal Upadhyaya Shekhawati University (Affiliation of colleges by Universities) Regulation, 2018 i.e. Rs. 15 Lakh FDR per programme for Arts, Science & Commerce Faculty and Rs. 35 Lakh FDR per programme for Professional courses for fresh, extension and temporary affiliation. The college will deposit enhanced endowment

fund, if the final judgement of the Hon'ble High Court Rajasthan out comes in favor of University till date norms of endowment fund may be applicable as per previous Academic Year. The non-deposition of FDR will be subject to de-affiliation irrespective of Inspection Report.

3. The Cost of affiliation form will be Rs. 1,000/- per affiliation form for the session

4. For extension of Temporary Affiliation fee will be charged 50% amount as per above chart for B.A., B.Sc, B.Com. Pass. Course, M.A., M.Sc., M.Com. for other professional Courses full fee will be charged.

5. Increase Intake affiliation fee will be charged as per Section wise i.e. Rs.73,200/- per Section. (10% fee will be increased on the basis of amount of basic fee of previous year

Rs. 66,550/-)

The Academic Colleges applying for Fresh/Increase intake/ Additional Subjects are required to pay an Inspection fee of Rs. 10,000/- each. And B. Ed., M. Ed., and Int. course colleges are required to temporary affiliation pay an Inspection fee of Rs. 10,000/- The inspection fee of Rs.20,000/- (As per BOM Resolution No. 33 Dated 06.09.2017 and Resolution (Table Agenda) No. 14 dated 28.03.2018) of the final judgement of the Hon'ble Court comes in favour of the university.

7. It is also clarified that seats which will be requested by the College for increase intake mentioned in the affiliation form for temporary affiliation, may be given by the University as per University affiliation regulations 2018 and as per the statute of the University after inspection done by the Inspection Team & Decision taken by the BOI as

per University Affiliation rules.

8. No Objection Certificate of the State Government must be uploaded and submitted along

with the affiliation forms for temporary extension and new course.

9. The existing Colleges will be required to fill up AISHE code. The new Colleges will apply for new AISHE Code. The College who have already taken AISHE code write Number in the Box.

10. Demand Draft will be payable in the favor of REGISTRAR, PANDIT DEENDAYAL

UPADHYAYA SHEKHAWATI UNIVERSITY, SIKAR.

- 11. The hard copy to be deposited by the College in the Academic Section with the date i.e. one week from expiry of date of online affiliation form given by the University failing which within seven days Rs. 500/- per day will be charged from the concerned College till 07-01-2020
- 12. 18% GST will be charged on Total fee (9% CGST+9% SGST) if the final judgment of the Hon'ble Court comes in favor of the University.
