





**NOTIFICATION**  
**RESEARCH ELIGIBILITY TEST : RET-2023**  
For Admission to Ph.D. Programme

**ELIGIBILITY:**

(1) Candidates who have completed:

1. A 1-year/2-semester master's degree programme after a 4-year/8-semester bachelor's degree programme or a 2-year/4-semester master's degree programme after a 3-year bachelor's degree programme or qualifications declared equivalent to the master's degree by the corresponding statutory regulatory body, with at least 55% marks in aggregate or its equivalent grade in a point scale wherever grading system is followed

or equivalent qualification from a foreign educational institution accredited by an assessment and accreditation agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country to assess, accredit or assure quality and standards of the educational institution.

A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/Differently-Abled, Economically Weaker Section (EWS) and other categories of candidates as per the decision of the Commission from time to time.

Provided that a candidate seeking admission after a 4-year/8-semester bachelor's degree programme should have a minimum of 75% marks in aggregate or its equivalent grade on a point scale wherever the grading system is followed. A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/Differently-Abled, Economically Weaker Section (EWS) and other categories of candidates as per the decision of the Commission from time to time.

- (2) Candidates who have completed the M.Phil. programme with at least 55% marks in aggregate or its equivalent grade in a point scale wherever grading system is followed or equivalent qualification from a foreign

educational institution accredited by an assessment and accreditation agency which is approved, recognized or authorized by an authority, established or incorporated under a law in its home country or any other statutory authority in that country to assess, accredit or assure quality and standards of educational institutions, shall be eligible for admission to the Ph.D. programme. A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/OBC (non-creamy layer)/Differently-Abled, Economically Weaker Section (EWS) and other categories of candidates as per the decision of the Commission from time to time.

**RET-2023 Exam will be held according to the rules given in the UGC Notification dated 07/11/2023 and University of Rajasthan Jaipur Ordinance-124.**

**RESERVATION:**

During allotment of Supervisors, vacancies in each subject will be filled as per reservation norms of Government of Rajasthan. If candidates from reserved categories are not available, vacancies may be filled by General candidates as per the UGC rules.

**FEE STRUCTURE:**

Fees will be Rs. 2000/- for General/OBC/MBC/EWS categories and Rs. 1500/- for SC/ST and Specially Abled (More than 40% disability) categories. The last date of submitting online application is 26/08/2023 (Till 11.59 PM). The entrance examination will be held on 06/09/2023. Payment will be made online through e-mitra/ICICI payment gateway system only.

**SCHEMIE OF TEST:**

The examination will consist of two papers, conducted in a single sessions. Paper-I consisting of 50 Multiple Choice Questions (MCQ) (One mark of each question) and Paper-II consisting of 50 Multiple Choice Question (MCQ) (One mark of each question). There will be no negative marking.

**PAPER-II (Duration 01.30 hours):**

This paper will be separate for each subject and will consist of 50 MCQ. There will be no negative marking. The syllabus for this paper will be the same as that of UGC.CSIR NET examination.

Paper-II will be evaluated only for those candidates who are able to secure the minimum qualifying marks in Paper-I as per the table given below:

- \* Students who have secured 50% marks in the entrance test are eligible to be called for the interview.
- \* A relaxation of 5% marks will be allowed in the entrance examination for the candidates belonging to SC/ST/OBC/differently-abled category, Economically Weaker Section (EWS), and other categories of candidates as per the decision of the Commission from time to time.
- \* University will decide the number of eligible students to be called for an interview based on the number of Ph.D. seats available.
- \* Provided that for the selection of candidates based on the entrance test conducted by the University a weightage of 70% for the entrance test and 30% for the performance in the interview/viva-voce shall be given.

Roll number and name of candidates applying for appearing in the Research Eligibility Test will be uploaded on the University website. Candidates who have applied for the test will be required to download their admit card form the University website 5 days.
