To ensure transparency in the examination system, and in the interest of the candidates, the (i) Provisional Answer Keys; (ii) Scanned Images of OMR Answer Sheets duly filled by the candidates; and (iii) Copy of the Question Booklets (Set-wise) as provided by the University; in respect of aforesaid Written Examinations have been uploaded on the University Website under “**Recruitment Section**” for perusal of all the interested candidates who appeared in the Written Examinations.

In respect of Written Examinations conducted for recruitment to the post of (i) Assistant Professor in Geography (Test Paper Code 22); and (ii) Assistant Professor in Legal Studies (test Paper Code 55); it is notified for information of all concerned candidates that due to printing error/mistakes in Question Booklet(s), the University on the recommendation of the Committee constituted for the purpose has decided that grace marks shall be given to all candidates in respect of Questions (including Questions which were printed in single language) which were missing/not printed in the Question Booklet.

For every missing question (whether bilingual or Monolingual), 01 grace mark for each question shall be given to all candidates.

Challenges made by the candidate(s) will be verified by the University. ***If the challenge of any candidate is found correct, the Answer Key will be revised and applied in the response of all the candidates accordingly.*** Based on the revised Final Answer Keys, the **result will be prepared and declared** on the University Website. No individual candidate will be informed about the acceptance/non-acceptance of his/her challenge. **The key finalized by the University after the challenge will be final and no further communication will be entertained in this regard.**

Procedure for Challenge of Provisional Answer Key

1. Please go to Official University Website (<https://shekhauni.ac.in/>).
2. Click on the “**Recruitment Section (Ongoing Recruitment)**” tab and search for the “**Public Notice: Challenge of Provisional Answer Key, Display of Scanned Images of OMR Answer Sheets and Question Booklets for Written Examinations conducted on 27th May 2024 (Monday) for recruitment to the posts of Assistant Professor in various Teaching Departments and Assistant Librarian**” and click on it.
3. A Public Notice PDF file will be opened on the screen.
4. **Click on the link** provided (under Para 4) in the said PDF file. **A login window will open.**
5. Enter the **login credentials (i.e., Registration Number and Date of Birth)** and press the login button.
6. A page along with specific links will be displayed on the Screen to see the **(i)** Question Booklets; **(ii)** Provisional Answer Keys; and **(iii)** OMR Answer Sheets. A link with the heading “**Challenge Provisional Answer Key**” is provided/available on this page.
7. In case of any discrepancies in the Provisional Answer Keys, candidates can submit their representation/objection(s) by clicking on the link “**Challenge Provisional Answer Key**”.
8. **Candidates can raise objection(s)/representation(s) against Provisional Answer Key(s) answer by providing relevant supporting documentary proof** for the same. Candidate is required to **upload (all documents to be put in a single pdf file)** under the specified link.
9. After uploading of the objection/representation along with relevant supporting documentary proof (*all documents in a single pdf file*), click on “**Save your Claim and Pay Processing Fee Finally**”.
10. Select Mode of Payment and Pay a **non-refundable processing fee of Rs.500.00 (Rupees Five Hundred) only** for each Answer Key challenged. Make payment through Debit card/Credit Card/Net Banking/Paytm/UPI payment modes.
11. The claims will be saved finally after successful payment of requisite processing fee.

- a) No challenge will be entertained without receipt of the processing fee.
- b) The Challenges will not be accepted through any other mode.
- c) No representations received after due date will be accepted/entertained under any circumstances.
