Course Objectives

The course introduces the classical as well as contemporary theoretical traditions in IR which developed in both eastern and western traditions. The course aims to provide theoretical lenses through which the students may decipher as to what shapes the behaviour of nation-states in an international system, how international systems determine complex engagement among the nations, and how to explain interconnectedness and the presence of transnational actors. The course also discusses alternative critical approaches to IR.

The course will also help the students with a thorough understanding of phenomena such as war, peace, conflict, cooperation, aggression, and alliances among the nations.

Course Objectives

The course is about how politics has unfolded in India since independence. The first unit discusses the influence of the colonial past and freedom struggle on the nature of the state in independent India. The remaining three units are designed to explore politics in India against the backdrop of its ever changing socio-economic milieu and are structured around four broader themes—politics of caste, class and gender; political parties and electoral politics; politics of religion, region and language and; people's movement.

Learning Outcomes

The students will be able to understand state and democracy in India in the broader context of its socio-economic variables which shape political developments on a day to day basis. They will also develop analytical skills to make sense of the complexities of the interplay of formal and informal institutions in a diverse democracy like India.
