General Instructions:

1. The qualifications, eligibility and other conditions shall be as per the UGC regulations and guidelines (amended from time to time) as adopted by the State Govt. vide letter dated 19.08.2020.
2. The prescribed application form can be downloaded from the University website: www.shekhauni.ac.in
3. The applicants are required to submit filled application forms along with required relevant self attested documents to the Registrar, Pandit Deendayal Upadhyaya Shekhawati University, Sikar on or before the last date i.e. 05.08.2024
4. Interested candidates are required to deposit Rs. 500/- (Rs. 250/- for SC/ST applicants) application processing fees (Non Refundable) in the form of Account Payee Cheque/DD in favour of Registrar, Pandit Deendayal Upadhyaya Shekhawati University, Sikar.
5. Applications received for the empanelment as guest faculty up to the last date as notified by the University will be scrutinized by the Scrutiny Committee on the basis of criteria for shortlisting as mentioned in the Table-1 for Assistant Professor and Table-2 for Associate Professor and Professor.
6. The marks for Scrutiny shall be awarded on the basis of Academic Record and Research Performance by the Scrutiny Committee as per the UGC Regulations and Guidelines.
7. After scrutiny of the forms, the list will be displayed on the University website. The Scrutiny Committee will prepare the final merit list.
8. The short listed candidates (1:3 ratio) will be called for counselling cum document verification. Such candidates are required to bring their original documents, experience certificate, Govt. issued ID card such as Aadhar, Driving License etc, Reprints of research papers/articles, published books, and other relevant documents. In case, the candidates fail to bring originals their application would not be considered for the above said purpose.
9. The superannuated teachers may also be considered for engagement as Guest Faculty subject to maximum age limit of 65 years as per State Govt. Rules.
10. The empanelment process of the guest faculty is being made for the smooth functioning of the various teaching departments for the academic session 2024-25. Hence, empaneled candidates shall have no claim for extension or permanent appointment as it is a time gap interim engagement on requirement basis.
11. **The remuneration will be paid to the empaneled guest faculty as approved by the BOM meeting dated 15.10.2022.**
12. Only those candidates who have retired from Govt. Universities or Govt. Colleges or Govt. Research Institutes will only be considered for empanelment as Associate Professor/ Professor.
13. **Validity of empaneled guest faculty will be for Academic Session 2024-2025 only.**
14. Incomplete form will be rejected without any notice.
15. The University reserves the right to empanel and not to empanel guest faculty members.
16. The empaneled guest faculty will not be given the benefit of allowances, pension,

17. gratuity, leave, CCL etc. as admissible to the regular teachers.
 18. The University reserves the right to alter / insert any corrections / additions in the notification.
 19. Candidate needs to submit enclose **Affidavit and Undertaking** and bank details at the time of reporting for empanelment.

TERMS AND CONDITIONS

(For Empanelment of Guest Faculty under Vidhya Sambhal Yojana)

Session 2024-25


1. The empanelment of the guest faculty members shall be executed on the following terms & conditions:
 - (i) For smooth conduction of the activities of the University Academic Departments, the empanelment of the guest faculty members shall be made on purely temporary basis for the academic session 2024-2025 only or up to the regular appointment of the faculty members, whichever is earlier.
 - (ii) The empanelled guest faculty members would have no any right to claim any kind of regular appointment in the University on the basis of this empanelment.
 - (iii) Empanelled guest faculty members, who wish to apply for recruitment on regular teaching positions will have to apply fresh. No preference whatsoever will be given to the empanelled guest faculty members for recruitment on regular teaching positions. University will treat them as a fresh candidate like other applicants. The Empanelled guest faculty members have no right to make any such claim of permanency or regularization or extension of his / her empanelment and/or a claim to treat him / her for being a regular employee consequent upon this empanelment.
 - (iv) The guest faculty members will be engaged on purely temporary basis subject to his / her satisfactory performance in academic and related assignments allotted during the empanelment period. In case of unsatisfactory performance of any empanelled guest faculty, the empanelment shall be discontinued immediately without giving any prior notice.
 - (v) The guest faculty members will not be entitled for any kind of leave except University / Gazette holidays.
 - (vi) If any information / document furnished is found counterfeit/false/incorrect, the empanelment will be discontinued with immediate effect without giving any prior notice.
 - (vii) The guest faculty member has to report his/her duties on or before the date decided by the University failing which his/her empanelment may be cancelled automatically.
 - (viii) The guest faculty members shall be bound to act in conformity with rules of the University as well as a code of professional ethics as formulated by the UGC and other competent bodies.
 - (ix) Any empanelled guest faculty member found to be involved in malpractices or guilty of misconduct or misdemeanor shall be debarred and punished as per the rules.
 - (x) A teacher working at more than one place simultaneously shall render himself liable to strict disciplinary action including seizing of empanelment.

2. A fixed remuneration per class (One hour Duration) shall be admissible to the guest faculty members empanelled as Assistant Professors, Associate Professors and Professors as per the following terms and conditions:

- (i) Remuneration shall be paid to the guest faculty as per the details given below for teaching and related works of the teaching Department and the University for the empanelment period as per the circular of the Govt. of Rajasthan vide letter No. P.6(2) / Finance / Gen. A&F Rules / 2021 Dated 30-03-2021 which has been approved by the BOM:


- (ii) The said remunerations, as mentioned above, does not attract any dearness allowances or any other allowances or perks over and above such specified remuneration.
- (iii) In addition to classroom teaching, the guest faculty members shall have to perform other academic non remunerative duties and activities assigned by the University from time to time.
- (iv) The guest faculty members will have no right to receive any benefits admissible to regular employees of the University including health and accident insurance, life insurance, sick-leave, CCL and/or vacation etc. The guest faculty members shall have to pay all taxes due in respect of the remuneration.
- (v) The Guest Faculty will not be given the benefit of any other allowances, pension, gratuity and leave etc. as admissible to the regular teachers.
- (vi) The payment of taxes including the income tax will be the Sole responsibility of the guest faculty him/herself. However, tax deduction at source (TDS) will be affected against the payable remuneration at applicable rates as per the prevailing laws, rules and regulations.
- (vii) If required empanelled guest faculty members will have to take online classes also.
- (viii) Such candidates who are superannuated from Govt. University/Govt. Colleges/Govt. Research Institutes would only be considered for empanelment as associate professor or professor, provided they possess requisite qualification (as per UGC).



3. The Good Academic Record shall be applicable as under for this empanelment process:

Good academic record” Wherever occurring in these provisions means an average of at least 55% Marks in three examinations preceding to master’s degree with at least 50% marks in graduation and any one of Secondary/High School, Higher Secondary/Senior Secondary or equivalent grades in the point scale wherever grading system is followed without including any grace marks and/or rounding off to makes it 55% or 50% as the case may be.

In case of Law subject the definition of good academic record as defined by the State Govt. shall be applicable.

QUALIFICATIONS AND ELIGIBILITY (For Empanelment of Guest Faculty under Vidhya Sambhal Yojana) Session 2024-25

QUALIFICATIONS:

Minimum Qualification for empanelment of Guest Faculty as Assistant Professor, Associate Professor and Professor shall be as per the “UGC Regulations on Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education, 2018” and amendments as notified by the UGC from time to time and as adopted by State Govt.

1. The empanelment of Guest Faculty as of Assistant Professor, Associate Professor and Professor shall be on the basis of merit prepared by the Scrutiny Committee.
2. The National Eligibility Test (NET) or an accredited test (State Level Eligibility Test SLET/SET) shall remain the minimum eligibility for appointment of Assistant Professor.
3. The candidates who have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulation, 2009, or the University Grants Commission (Minimum Standards and Procedure for Award of M. Phil./Ph.D. Degree) Regulation, 2016, and their subsequent amendments from time to time, as the case may be, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for Assistant Professor.
4. The award of degree to candidates registered for the M. Phil./Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances / Bye-laws / Regulations of the Institutions awarding the degree. All such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for Assistant Professor subject to the fulfillment of the following conditions:
 - The Ph.D. degree of the candidate has been awarded in regular mode only;
 - The Ph.D. thesis has been awarded by at least two external examiners;
 - An open Ph.D. viva voce of the candidate has been conducted;
 - The candidate has published two research papers from his/her Ph.D. work out of which at least one is in a refereed journal;
 - The candidate has presented at least two papers, based on his/her Ph.D. work in conferences/seminars sponsored/funded/supported by the UGC/ ICSSR/ CSIR or any similar agency.

(The fulfillment of these conditions is to be certified by the Competent Authority of the concerned University).

-
5. The clearing of NET/SLET/SET shall not be required for candidates in such disciplines for which NET/SLET/SET has not been conducted.
 6. A minimum of 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed) at the Master's level shall be the essential qualification for teachers and other equivalent cadres at any level.
 7. A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC) (Non-creamy Layer)/Differently-abled ((a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid-attack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness; (e) Multiple disabilities from amongst persons under (a) to (d) including deaf-blindness) for the purpose of eligibility and assessing good academic record. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.
 8. A relaxation of 5% shall be provided, (from 55% to 50% of the marks) to the Ph.D. Degree holders who have obtained their Master's Degree prior to 19 September, 1991.
 9. A relevant grade which is regarded as equivalent of 55%, wherever the grading system is followed by a recognized university, at the Master's level shall also be considered valid.
 10. The time taken by candidates to acquire M. Phil. and/or Ph.D. Degree shall not be considered as teaching/ research experience to be claimed for appointment to the teaching positions. Further the period of active service spent on pursuing Research Degree simultaneously with teaching assignment without taking any kind of leave, shall be counted as teaching experience.

ELIGIBILITY (A or B):

A.

- (i) A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign university.
- (ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedures for the Award of M. Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET: *Provided*, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Byelaws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions:
 - The Ph.D. degree of the candidate has been awarded in a regular mode;
 - The Ph.D. thesis has been evaluated by at least two external examiners;
 - An open Ph.D. viva voce of the candidate has been conducted;
 - The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal;
 - The candidate has presented at least two papers based on his/her Ph.D. work in conferences/seminars sponsored/funded/supported by the UGC / ICSSR/ CSIR or any similar agency.

(The fulfillment of these conditions is to be certified by the Competent Authority of the concerned University).

Note: NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/SET.

- B.** The Ph.D. degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following: (i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).



Note: The Academic score as specified in the tables for universities shall be considered for short-listing of the candidates.

Associate Professor

- (i) A good academic record, with a Ph.D. Degree in the concerned/allied/relevant disciplines.
- (ii) A Master's Degree with at least 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed).
- (iii) A minimum of eight years of experience of teaching and / or research in an academic/research position equivalent to that of Assistant Professor in a University, College or Accredited Research Institution/industry with a minimum of seven publications in the peer-reviewed or UGC-listed journals and a total research score of Seventy-five (75) as per the criteria given in Appendix II, Table 2 of UGC Regulation, 2018.

- For joint supervision of research students, the formula shall be 70% of the total score for Supervisor and Co-supervisor. Supervisor and Co-supervisor, both shall get 7 marks each.
- *For the purpose of calculating research score of the teacher, the combined research score from the categories of 5(b). Policy Document and 6. Invited lectures/Resource Person/Paper presentation shall have an upper capping of thirty percent of the total research score of the teacher concerned.
- The research score shall be from the minimum of three categories out of six categories.


